ORDER

This matter is before the Court on Plaintiffs’ Motion For Permission To Continue With The Settlement Notice Plan, And Report Regarding Mailing Of Settlement Postcards (Doc. #851) filed August 28, 2018. The motion seeks the Court’s permission to send notices of settlement to class members and schedule a final settlement hearing date. Id. at 1-2.

On July 27, 2018, the settlement administrator mailed settlement postcards to 34,909 class members. Plaintiffs’ Memorandum In Support Of Motion For Permission To Continue With The Settlement Notice Plan, And Report Regarding Mailing Of Settlement Postcards (Doc. #852) filed August 28, 2018 at 2. The postcards allowed class members to provide class counsel updated contact information and informed class members of forthcoming notices of settlement and settlement checks. Notice of Settlement (Doc. #846-1). The postcards did not require class members to take any action if they had received a postcard at the proper mailing address. Id.

After mailing and re-mailing postcards and updating addresses for class members, only 129 postcards remain undeliverable. Plaintiffs’ Memorandum In Support Of Motion For Permission To Continue With The Settlement Notice Plan, And Report Regarding Mailing Of Settlement

Postcards (Doc. #852) at 4. During this process, class counsel also received updated contact information directly from 1,182 class members, and 530 class members confirmed their current address. Id. For reasons stated above and in Plaintiffs' Memorandum In Support Of Motion For Permission To Continue With The Settlement Notice Plan, And Report Regarding Mailing Of Settlement Postcards (Doc. #852), the Court sustains plaintiffs' motion.

IT IS THEREFORE ORDERED that Plaintiffs' Motion For Permission To Continue With The Settlement Notice Plan, And Report Regarding Mailing Of Settlement Postcards (Doc. #851) filed August 28, 2018 is **SUSTAINED**. Plaintiffs shall continue the notice plan as described in the Settlement Agreement (Doc. #832-1) filed May 21, 2018.

IT IS FURTHER ORDERED that the Court shall hold a final settlement approval hearing on **December 20, 2018 at 10:30 a.m.**
